#### INVITED SPEAKERS

### Benson Deng

Currently I run the computer and digital photography system at Waste Management in El Cajon. I speak to schools and Rotaries on behalf of my fellow countrymen and other Lost Boys. I'm a member of the Lost Boys Rotaract Club in Mid-City and am in my fourth semester at San Diego City College. With my brother Alepho, and cousin Benjamin, we wrote a book about our life in Africa. Titled *They Poured Fire on Us from the Sky*, it will be published and released on June 13, 2005.

Our village in Southern Sudan was attacked by Islamic extremists when I was seven years old. We fled a thousand miles across Sudan to Ethiopia on foot. The traveling was always by night and I hated this very much because we were not allowed to sleep and when I stepped on unidentified things in the dark like thorns, twigs and sharp stones, my feet were sore all the time. But I was not the only one; about twenty-five boys my age shared the same hardships. This stopped me from any complaints or crying. I was not wearing any shirt or jacket, just only my underwear all the way to Ethiopia.

#### Erin Callahan

Erin Callahan is Amnesty International's Regional Director for the Western United States, and previously managed media relations for Amnesty International USA. She has twelve years of experience with U.S. presidential campaigns, serving as communications director in Iowa, New Hampshire, Ohio and California. She also served as Communications Director for U.S. Senator Barbara Mikulski and as Emergency Services Manager for Alameda County Sheriff's Department

In addition, she was a lecturer at Cornell University, School of Industrial and Labor Relations, conducted political seminars for the National Democratic Institute's Eastern European delegations, was a policy advisor for Mexico City based Miguel Agustín Pro Juárez Center for Human Rights, and produced a radio series on youth culture in Israel and Palestine for National Public Radio.

She is a graduate of UC Berkeley and has a master's degree in broadcast journalism.

#### Victor Condé

Victor Condé is a lawyer with fourteen years experience teaching human rights in law school and at the graduate school level. He is an expert on international and comparative human rights and humanitarian law and international criminal law. Professor Condé is part of the AIUSA Legal Support Network and the AIUSA Human Rights Education Network for the Western Region and is President of Human Rights Aware, an NGO whose mission is to teach teachers how to teach human rights. He is the author of A Handbook of International Human Rights Terminology and Human Rights in the United States: A Dictionary and Documents, published in 2000. The latter book features a forward by Bill Schulz, AIUSA Executive Director. In addition, he teaches once a year at the International Institute in Strasbourg, France.

#### **Ochan Otim**

Dr. Otim has been an active advocate for peace, human rights, and internationalism for many years. His charitable affiliations include Amnesty International, African Educational Program, Kacokke Madit, Samalitan Christian Children's Fund, Inc., Ugandan Community Organization in California, and Nile Heritage Foundation. The mission of Friends for Peace in Africa (FPA) is to facilitate and mediate through dialogue, advocacy, and empowerment, the implementation of conditions that enable every individual in all regions of Africa, to live and develop to his/her fullest potential in an atmosphere of peace.

#### Mahsa Abassi

Mahsa Abassi has been part of the Huntington Beach Amnesty International group for three years. She is currently co-leading the group with Darcie Olsen.

# **Aaron Cohen**

Aaron Cohen works as a special agent specifically in the area of human rights. As an activist and author with more than a decade of exposure to human rights intelligence, military paramilitary slave retrievals, and to turning states' evidence against hostile governments such as Sudan and Vietnam, his career follows his message of freedom and peace, and his reports and assessments have contributed to the body of knowledge published by the US State Department in their annual Trafficking in Persons report. "It's this experience working undercover for human rights and seeing the victims up close that has motivated me to write *The Jubilee Prophecy*," he says of his book about Peace through Music and modern slavery. Aaron Cohen is the executive director of The United States International Mission (USIM), has served as a consultant with the Protection Project at Johns Hopkins University, with People for Children of the Ricky Martin Foundation, and as the executive director for the Jubilee Freedom Foundation, working with an array of world class entertainers, royals, religious leaders, and celebrities including the Dalai Lama, the Princess of Thailand, Bono of U2, and Perry Farrell of Lollapalooza.

#### Tony Cruz

Tony Cruz is the Amnesty International Corporate Action Network Coordinator for California and Hawaii. In the last few years, Tony has been active on LGBT issues and was formerly the chairman for Soulforce San Francisco, an interfaith gay advocacy organization working to end discrimination and violence spurred on by religious intolerance. He is employed as a social worker, helping those who have suffered traumatic brain injuries.

#### Kristina Elali

Kristina Elali has been involved with Amnesty International since 1991. She is a member of Group 178 Irvine, a trainer for Amnesty, and Western Regional Representative for the Special/Existing Initiative Fund Committee.

#### **Amanda Ellis**

# Tim Spann

Tim Spann has been active working towards abolishing the death penalty for seventeen years. He is the Death Penalty Coordinator for Southern California for Amnesty International. He is also the chapter coordinator for the San Diego chapter of Death Penalty Focus of California, a statewide death penalty abolition organization. He has traveled to many states across the U.S. in support of Murder Victims' Families for Reconciliation, a group comprised of surviving family members of homicide victims who speak out against capital punishment. Mr. Spann is also active in the San Diego Hillcrest chapter of Amnesty International USA.

# Raquel S-Saboor

Raquel has been a member of Amnesty since September 2004. She is part of the Huntington Beach and Irvine local groups. She is currently pursing her B.A. in Public Relations and Graphic Design from Cal State Fullerton. From the moment Raquel learned about human trafficking she has been dedicated to learn more about the issue and raise awareness in her community.
